## **OPEN PUBLIC MEETINGS ACT:**

## OLD BUSINESS

T-shirts were discussed and it was recommended they be made without dates on them so they can be used from year-to-year (Sam Marotta is the contact).

<u>Gas Station</u> - 10/2/17 - next meeting.

<u>Emerald Ash Borer</u> – Still waiting on clarification of which tree out front of the Municipal Building is an ash tree.

## **NEW BUSINESS**

<u>Master Plan</u> – Has to be approved by the Planning Board every 10 years. PB approved "as is" because it was a necessity to not miss the 10 year deadline. The caveat to approval was an open meeting to the public to create addendums and important things to add to the Master Plan.

<u>Green Team</u> – A discussion was held regarding the Green Team and fundraising and how to make sure that any fundraising money that is raised is received by the Green Team. A question was raised about the Green Team opening their own checking account. Also discussed was asking the CFO to put the Green Team in as a line item in the budget so as to maintain separate funds.
